In consideration of the acceptance of my child for participation in AFTER SCHOOL ATHLETICS PROGRAM, I hereby grant permission for my child to participate in the event and, to the extent permitted by law, I waive any and all claims for damages for death, personal injury, loss of property damage which I may have or which may hereafter accrue to me or my child, against the Diocese of Monterey, St. Patrick's Catholic School as a result of my child's participation in the activity/event as related to the nature, type or condition of the events involved, and/or with respect to the conditions of the sites involved, and/or with respect to the supervision provided and/or with respect to the activities performed, whether or not caused by the negligence (active or passive) of the Diocese of Monterey, St. Patrick's Catholic School.

This Waiver & Release is intended, to the extent permitted by law, to release and discharge in advance THE ROMAN CATHOLIC BISHOP OF MONTEREY, CALIFORNIA, A CORPORATION SOLE, also known as THE DIOCESE OF MONTEREY, St. Patrick's School and its officers, agents, and employees, from any and all liability relating to the events involved, site conditions, supervision, and/or activities connected with my child's participation in the above-named activity/event/program.

3. It is further understood and agreed that the Agreement, Waiver & Release is to be binding on my heirs and assigns.

4. Also, I hereby attest and verify that my child is physically fit and capable of participation in this Event.

5. I agree to inform my child to abide by the rules established by the chaperones, promoters, sponsors, officials or leaders of the event/activity/program, and to obey the directions given by any of them.

6. I have explained to my child that eligibility for and participation in this activity/event/program requires meeting and maintaining specific academic and conduct standards set by the school and/or Diocese, and that if the standards are not met or maintained, my child will not be eligible for participation.

I further and specifically understand and agree that no representations or warranties are or have been made by the Diocese or any of its employees, agents, sponsors, officials, leaders of affiliates mentioned above, with respect to the quality or safety of any events involved or with regards to any of the sites to be utilized or supervision provided or activities performed.

8. I understand that I am responsible for transporting my child to and from the activity/event/program or sports games listed. If I cannot do so: I hereby give permission for my child to be transported to and from the activity/event by (school checks):
