



St. Patrick School Independent Study for Distance Learning Assignment Contract- Short Term

1. The Registrar will notify the teacher and Distance Learning Coordinator regarding the need for distance education.
2. Supplies will be sent home with your child or will need to be retrieved by parent from office
3. Distance Learning Coordinator or teacher will give code to enroll your student in the Distance Learning Google Classroom per grade level, and will email you instructions in regard to access and calendars or packet (depending on grade level).
4. Teacher will provide a Distance Learning Calendar (including zoom links) for synchronous and asynchronous instruction during absence.
5. Grades 4-6 will submit assignments through Google classroom per due dates noted on the calendar; K-3 will return packets and all work upon return to school.
6. All assessments will occur upon return to school during homework club time

PARENT/GUARDIAN/CAREGIVER RESPONSIBILITIES:

I understand that the major objective of Independent Study/Distance Learning is to provide an educational alternative for my student due to isolation.

I understand that: · Learning objectives are consistent with and evaluated in the same manner that they would be if he or she were enrolled in a traditional school program. · I am responsible for supervising my student while he or she is completing the assigned work and for ensuring the submission of all completed assignments necessary for evaluation. ·I understand that there will be occasions when we will have to print out materials and therefore will ensure access to a printer for assignments. Subject	Assignment/Objective/Materials Description of what pupil assigned in distance learning calendar & described in Loom (dependent upon grade level)
Religion	Content covered asynchronously through text and online supports through Catholic Brain; daily synchronous prayer with class ; spiritual reflection time with Mrs. Anderson (Zoom)
ELA	Content covered asynchronously through (packets,texts, novels, projects) and online support and tools (IXL, Newsela, BookFlix,Epic,etc), and synchronous instruction completed through Zoom daily - start TBD and dependent upon grade level
Math	Content covered asynchronously through assigned texts and online supports (IXL, fluency practice, etc) and synchronous instruction completed through Zoom daily - start TBD and dependent upon grade level
Social Studies/Science	Content covered asynchronously through assigned texts, choice boards, and projects. Scheduled synchronous time with teacher TDB, depending on assignment or project
Music, Art	Music and Art will occur synchronously with Mrs. Anderson and Mrs. Vaccaro weekly.



Frequently Asked Questions

Independent Study/Distance Learning Short Term

How often do I have to meet with my teacher/ independent study coordinator?

Your child will meet with class synchronously per distance learning calendar. A check in with the independent study coordinator would occur on an as needed basis. Assessments will occur upon return to school. Homework club is an option on M, T, and Th per distance learning calendar, and grade level.

What hours are available for meeting with my teacher?

Meeting times (as needed) are individually scheduled with the teacher to accommodate family and teacher schedules. Homework club will be M, T, Th from 3-3:30PM

Is this program different from your independent/distance learning program? Yes. Your child is being placed in this program on a short term basis and those that chose the independent program commit to 20 days. Assessments also will be done upon return to school and not virtually. Also, meetings with independent study coordinator will be less frequent (mainly via email) as this is a short term need.
